It has been made clear by concerned residents as well as the Board of Zoning Appeals that the current location you have chosen is not properly suited for the size and scope of the project you propose. As you know, we have repeatedly encouraged other locations for the new school in meetings between members of this board and administration and the Board of Education. In addition, we advised that the location you chose was not a good one from the standpoint of both traffic and lack of sewer connectivity. Lastly, when your administration chose to proceed with that location we advised that the Conditional Use Permit should be applied for before exercising any land contract options. That advice was ignored.

It appears the Board of Education believes the only course of action is to litigate the matter. Please know that we do not believe this is a sound strategy. First, the township will fully defend the decision of the Board of Zoning Appeals in court. This will undoubtedly result in lengthy delays that could take years and cost both the township and Board of Education thousands of dollars in legal fees. Second, the damage to both entities in the eyes of the public will be long lasting and detrimental to future relations. Third, the potential to damage the credibility of the Board of Education if it chose to sue the township would be similar to the decade of lost credibility that revolved around the purchase of the county home property.


