A. FISCAL OFFICER / CEMETERY SEXTON - Amy L. Dawson

- We are 50% through the calendar year and we were at 60% of the budgeted revenue and 41% of the budgeted expenditures; we are well within budget
- Cemetery we are thinking about working with Painesville City for Wreaths Across America on December 15th; anyone who would like more information on Wreaths Across America and placing wreaths on soldiers graves in Concord Township Cemetery on December 15th, contact myself or Karen Warner

DEPARTMENT REPORTS:

A. ADMINISTRATION DEPT. - Mr. Rose, Administrator

 On July 15, 2018, the Ohio Fire Chiefs' Association presented Deputy Chief Ron Terriaco of the Concord Township Fire Department with the 2018 Distinguished Service Award.

This honor was bestowed on Deputy Chief Terriaco in recognition of his leadership not only within the Ohio Fire Chiefs' Association but also throughout the State of Ohio.

Deputy Chief Terriaco is a leader in Ohio representing the National Fallen Firefighter's Foundation's Local Assistance State Team (LAST) Team. This team's primary mission is to "provide assistance and comfort to the family and department and help with filing Department of Justice – Public Safety Officer's Benefits as well as state and local benefits."

In response to a line-of-duty-death in Ohio, Deputy Chief Terriaco coordinates the efforts of the Ohio LAST Team. The Team provides a multitude of services to families, including support with funeral plans and ongoing assistance with benefits.

In addition to coordinating Ohio's LAST team, Deputy Chief Terriaco donates many hours every year traveling to educate fire departments on the 16 Firefighter Life Safety Initiatives, a program sponsored by the National Fallen Firefighters Foundation. The Deputy Chief's goal has always been to work himself out of a job with Ohio's LAST team by promoting safety at every level of the fire service.

Concord Township and Concord Township Fire Department wishes to extend a local appreciation and congratulations to Deputy Chief Ron Terriaco for being honored with the Distinguished Service Award from the Ohio Fire Chiefs' Association.

- On July 5th Township Hall and Fire Station #1 experienced a lightning strike; the event caused a
 loss of the computer network and phone system for approximately 18 hours; the telephone network
 switch boards have been replaced along with the network switches for our internet connectivity
 restoring all systems; we have ordered three (3) new computers; our connectivity to the County
 dispatch network was not affected
- State Route 44 will experience lane closures between I-90 and State Route 84 for approximately six (6) week
 This is an ODOT project to make repairs to the north and south bound bridges over Kellogg Creek

- · Mount Royal subdivision road repairs are ongoing:
 - July 19th the road surface will be swept prior to an application of road tar and #8 limestone
 - It will be rolled and compacted and allowed to tighten up over the weekend
 - We recommend everyone to drive slowly during this period as there will be some loose stone
 - Use caution on freshly laid asphalt, as it is very hot and sticky
 - Do not drive, walk, or allow pets on this surface unless otherwise allowed to proceed by the personnel present on the jobsite
- There are two (2) more summer concerts remaining
- Concord Community Day is on August 11th; schedule of events are posted on the website

AUDIENCE:

- Boy Scout #1 asked if there was a new grocer going into Reider's; Mr. Galloway stated that there
 has been a lot of work done by the Township and there is a grocer interested; it is on hold as the
 company that owns the real estate, known as Gristmill, is in foreclosure with their bank; it is currently
 going thru the legal process; Mr. Malchesky added the interested grocer would like to find out who
 the new landlord will be before proceeding
- Boy Scout #2 asked if the program that purchased the houses along 608 by Jordan Creek was run through the Township or Painesville Soil and Water; Mr. Galloway responded the Township; Boy Scout #2 asked if the program was still available; Mr. Malchesky responded the Grant for Jordan Creek was a joint effort with Township, Soil and Water, Stormwater and FEMA; the Township got in on the tail end of what the program allowed so we just got in; whether or not they open up that program again or there is a different grant out there we will wait and see; prior to that the condos in front of the dam on Prouty Road was a USDA grant; they come, they go, so you look to different places to find them
- Boy Scout #3 asked if the Township has a traffic plan for heavy traffic on 608 during peak school
 times; Mr. Galloway responded that will not be our traffic plan as it falls within the ODOT realm
 since 608 is a state route; we certainly have opinions and we did ask about a turn lane which is not
 going to happen at this time; Riverside Schools is directly negotiating with ODOT; Mr. Malchesky
 also commented that the school provided ODOT with a study regarding this issue

- B. VOTE RESOLUTION 2018-21 ADOPT LAKE COUNTY SOLID WASTE 5 YEAR PLAN. Mr. Malchesky moved to adopt the following resolution:

RESOLUTION NO. 2018-21

A RESOLUTION BY THE CONCORD TOWNSHIP BOARD OF TRUSTEES APPROVING THE LAKE COUNTY SOLID WASTE MANAGEMENT DISTRICT AMENDED PLAN 5-YEAR UPDATE MARCH 2018.

WHEREAS, the Board of County Commissioners of Lake County established the Lake County solid Waste Management District (the "District"), and established and convened a "Solid Waste Management Policy Committee" (the "Policy Committee") in accordance with R.C. 3734.54, and prepared a "Solid Waste Management Plan" for the District (the "Plan") as required by R.C. 3734.54; and

WHEREAS, the Concord Township Board of Trustees approved the final draft of the Plan of the District and, on September 1, 1992, the Plan was subsequently approved by the Ohio Environmental Protection Agency (the "EPA"); and

WHEREAS, The Solid Waste Management District Policy Committee pursuant to law has reviewed the original Plan and it has issued a Plan Update for the original Plan, and has adopted the aforesaid five (5) year Solid Waste Plan Update as of April 26, 2018; and

WHEREAS, upon receiving or determining approval of the five (5) year Update Plan by (1) the Board of Lake County Commissioners, (2) the legislative authorities of the municipal corporation having the largest population within the boundaries of the County of the District, and (3) at least sixty percent (60%) of the population of the combined municipal corporations and townships within the District, the District Policy Committee must ratify the update Solid Waste Management Plan prior to submitting it to Ohio EPA for approval;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees, Concord Township, Lake County, State of Ohio as follows:

Section 1. That the Lake County Solid Waste Management District Amended Plan 5-Year Update

March 2018 is hereby approved; sucl Plan presently on file with the Township's Fiscal Officer.

<u>Section 2</u>. That the Township's Fiscal Officer is hereby instructed to forward a certified copy of this Resolution to the Lake County Solid Waste Management District Coordinator, Attn: Timothy Gourley, 105 Main Street, P. O. Box 490, Painesville, Ohio 44077.

<u>Section 3.</u> All formal actions of this Board of Trustees concerning the passage of this Resolution were adopted in an open meeting, and that all deliberations of this Board of Trustees or any of its Committees, which resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Codified Ordinances and Section 121.22 of the Ohio Revised Code.

NOW, THEREFORE, this Resolution shall be in full force and effect upon its passage and approval by the Board of Trustees and as further provided under Ohio law.

C. RESOLUTION 2018-22 STANDARD FIRE CODE. Mr. Malchesky moved to adopt the following resolution:

RESOLUTION 2018-22

A RESOLUTION BY THE CONCORD TOWNSHIP BOARD OF TRUSTEES ADOPTING THE 2017 OHIO FIRE CODE, AS AMENDED TO DATE, AS THE STANDARD FIRE CODE FOR THE TOWNSHIP.

WHEREAS, in order to properly protect the health, safety and welfare of the inhabitants of the Township, this Board considers it necessary and advisable to adopt the updated and more modernized 2017 Ohio Fire Code as the standard fire code pertaining to fire, fire hazards and fire prevention;

NOW, THEREFORE, BE IT RESOLVED BY THE CONCORD TOWNSHIP BOARD OF TRUSTEES, LAKE COUNTY, OHIO THAT:

<u>Section1.</u> Pursuant to Ohio Revised Code Section 505.373, the Board of Trustees hereby adopts the 2017 Ohio Fire Code, as amended to date and incorporated herein by reference, including any and all standards and appendices referenced therein, as the standard code for the Township pertaining to fire, fire hazards, and fire prevention.

Section 2. The Township Fiscal Officer, pursuant to the requirements of R.C. 505.373, is directed to undertake the following actions: (1) maintain a complete copy of the 2017 Ohio Fire Code, and its attachments and appendices, on file in the Township Office for inspection by the public; (2) keep copies of the 2017 Ohio Fire Code available for distribution to the public at cost; (3) certify a copy of this Resolution, together with a complete copy of the 2017 Ohio Fire Code, to the Lake County Law Library, located at 47 North Park Place, Painesville, Ohio 44077, to be kept on file there; and (4) post a notice of adoption of the 2017 Ohio Fire Code in five (5) conspicuous places in the Township for at least thirty (30) days, and also cause such notice to be published in a newspaper of general circulation in the Township once a week for three (3) consecutive weeks. This notice shall clearly identify the Code and state its purpose, and state that complete copies of the Code are on file with the Concord Township Fiscal Officer and the Lake County Law Library for

inspection by the public, and that the Fiscal Officer has copies available for distribution to the public at cost.

Section 3. The 2017 Ohio Fire Code as amended to date and its standards and appendices shall be in full force and take effect throughout the Township on the 31st day following the date the above notice is first posted in the Township.

Section 4. It is found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were conducted in an open meeting of this Board and that all deliberations of this Board that resulted in those formal actions were conducted in meeting open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code
