## Minutes of Concord Township Board of Trustees Meeting

Held on May 1, 2019

The Concord Township Board of Trustees met for a Regular Meeting May 1, 2019, at 7:30 pm, in Town Hall, located at 7229 Ravenna Road. Chairman Paul R. Malchesky called the meeting to order and Mr. Galloway led in the Pledge of Allegiance. Trustees present were, Caroline N. Luhta, Carl Dondorfer and Paul R. Malchesky.

### APPROVAL OF MINUTES:

April 3, 2019 Regular Trustees Meeting – approved as written, Mr. Dondorfer abstained.

#### TREASURER'S REPORT:

- As of April 30th, we were 33% of the way through the calendar year. The Treasury Balance for the 19 Active Funds within the Township Treasury was \$6.2 million. The Treasury Balance includes \$1.4 million in funds set aside for specific projects. Year-to-date expenditures were 25% of the amount appropriated and revenue is at 47% received for 2019, so we are within budget. Call with any questions.

A. ADMINISTRATION DEPT. – Andy Rose, Administrator

- Trustees, our first Limited Home Rule Resolution is on today's agenda for first reading. It is a conformation of the Township's road system and who is responsible for each road.
- We are working on a walking path plan for the Jordan Creek property. We would like to thank the Lake Metro Parks for their assistance in the planning and design process.

### CEMETERY REPORT:

- Memorial Day: Please join us at 9:00 am on Monday, May 27, 2019 for a brief Memorial Day Service at Concord Cemetery, which is located on SR 608, just east of Fire Station #1. This is a time to honor and pay tribute to the Veterans buried in our cemeteries and remember loved ones that have gone before us.
- Planting in the Cemetery: No planting will be allowed in the 2004 in-ground cremation section; no trees shall be planted in the 2004 section. All trees and shrubbery, type and location, must be approved by the Cemetery Sexton; in-ground plantings will not be allowed until the monument is placed and it shall not encroach on the neighboring grave. Concord Township reserves the right to maintain plantings, which may include trimming or removal if deemed necessary by the Cemetery Sexton or Cemetery Superintendent and will not be replaced.
- Maintenance: Maintenance of the cemetery grounds has begun (turf building, seeding, etc.). The cemetery staff reserves the right to remove any live decorations and non-floral decorations not in keeping with the beautification of the cemetery.
- Prohibited Items: Glass of any kind (including gazing balls), styrofoam, birdhouses and feeders are prohibited.

#### B. FIRE DEPT. - Chief Sabo

- Introduction of Dr. DeCarlo, President-University Hospital Geauga Medical Center and the presentation of the Lucas Devices to Concord Fire Dept.
- **Activities Report for April** – 199 Total Runs; EMS - 133 events with 107 transports; Fire – 6 events (3 brush fires in Concord, 3 building fires outside Concord Twp.); 16 Mutual Aid Given, 10 Mutual Aid Received; **Fire Prevention Bureau** – 2 Plan Reviews, 34 Annual Inspections, 3 Follow Up, 16 Fire Protection System Testing, 16 Fire Alarm Tests; **Public Education** - 1 Knox Box Installation and 1 Knox Box return, 1 Adult Public Safety and fire extinguisher training.
- Concord Fire extends its thanks to Bob's Garage and Towing for the donation of vehicles for training purposes. These have been used to assist our firefighters in training on the new rescue pumper, 1375. We also thank Lubrizol Corporation for the use of their fire training facility to allow our firefighters to become familiar with the new foam system on 1375.
- Hydrants – The Concord Township Fire Department has begun its annual hydrant maintenance program. Concord's firefighters will flush and test individual hydrants between 9 am and 4 pm. This program will be ongoing into the summer months. Firefighters remain in the vicinity of each hydrant as they allow water to flow, perform necessary testing, then close up the hydrant. If a hydrant needs repairs, we send a request to the respective water company, who are the owners of the hydrants. Residents may notice a slight discoloration of their water when flushing is being completed in their neighborhoods. Running cold water for a few minutes before use should eliminate any discoloration.

#### C. SERVICE DEPT. – Frank Kraska, Service Director

- Service Dept. would like to extend a welcome to our new Trustee, Carl Dondorfer, and we look forward to working with you.
- Road construction has begun in the Township. Roads have been planed and full depth repairs completed. The week of May 6<sup>th</sup> Chagrin Valley Paving will chip seal the inner layer, weather dependent, on the following County and Township Roads:
  - ❖ Girdled Road
  - ❖ Morley Road
  - ❖ Concord Pointe Court
  - ❖ Danvers Drive
  - ❖ Brenel Drive
- Christian Avenue and Jason Avenue road replacement project has been complex with the discovery of utilities, gas and communication lines under the roads installed too shallow. The lines will need to be lowered in advance of the actual road improvements. Cable television and internet providers have been addressing their infrastructures and relocating as needed. Several gas line laterals are also in need of adjustment and Dominion may begin work next week. This additional work will create unexpected excavations in front yards and full restoration of these areas will be done upon the completion of the project over the next three to four months.
- Thank you to The Master Gardeners, Concord Garden Club and Klynn Nursery for donating three trees for our third annual Arbor Day Ceremony. One tree was planted at the entrance of Town Hall and the other two at the Old School House on Ravenna Road. Arborist Ben Askren demonstrated planting procedure and care instructions for the young trees.
- The annual brush and yard waste drop-off is scheduled for Saturday, May 18<sup>th</sup> from 8:00 a.m. – 2:00 p.m. and personnel will be on hand to help assist residents. Yard waste should be in biodegradable bags and is taken to a local recycle center for compost. Twigs and branches no greater than six inches in diameter will be accepted. No tree stumps, pallets, contaminated or processed wood such as lumber or railroad ties are accepted.
- Beginning May 20<sup>th</sup> we are pleased to announce we will allow residents (no contractors) to drop off yard waste (grass clippings, leaves, garden debris and small twigs) at the Service Dept., Monday – Friday from 6:00 am until 4:00 pm.
- The 2019 / 2020 Rock Salt Bid nearly increased by 30% from last year prices. With Lake County receiving the lowest bid in all of Ohio it still represents a minimum of \$50,000 increase to the Service Dept. and will cut into improvement programs outside the winter months.

- During the month of April, the Zoning Department processed 37 zoning permit applications and collected \$4,200 in fees. Of those permits, 12 were for accessory buildings, 8 decks, 6 fences, 3 wall signs, 2 single family dwellings, and 1 agricultural building, structural alteration, change of use, commercial alteration, pavilion, and swimming pool.

- Next week the Board of Zoning Appeals will meet on Wednesday evening at 7 pm, as there is one old case to review.




