A RESOLUTION BY THE CONCORD TOWNSHIP BOARD OF TRUSTEES TO IDENTIFY THE SYSTEMS OF PUBLIC ROADS, STREETS, AND HIGHWAYS WITHIN THE TOWNSHIP UNDER THE JURISDICTIONS OF THE STATE OF OHIO, COUNTY OF LAKE AND CONCORD TOWNSHIP, RESPECTIVELY, AND THE CORRESPONDING REQUIREMENTS OF CARE AND MAINTENANCE ESTABLISHED THERETO PURSUANT TO OHIO LAW.

Whereas, the State of Ohio, the County of Lake and Concord Township, respectively, all have systems of public roads, streets and highways within the boundaries of Concord Township and under their respective jurisdictions and control; and

Whereas, the Board of Trustees believes it is in the best interests of its residents to fully and properly identify the established systems of public roads, streets, highways under each governmental entity's respective jurisdiction and the attendant requirements for care and maintenance thereto by each governmental entity having such jurisdiction in accordance with Ohio law;

NOW, THEREFORE, BE IT RESOLVED, by the Concord Township Board of Trustees, Lake County, Ohio, as follows:

Section 1. That the Board of Trustees hereby sets forth a full and complete identification of the systems of public roads, streets and highways within the boundaries of Concord Township, and the jurisdictions and requirements of care and maintenance regarding these systems by the State of Ohio, the County of Lake, and Concord Township, respectively, pursuant to Ohio law, all as more fully set forth within attached Exhibit A and incorporated herein.

Section 2. It is found and determined that all formal actions of the Board of Trustees of Concord Township concerning and relating to the adoption of this Resolution were taken in an open meeting of the Board of Trustees of Concord Township and that all deliberations of this Board that resulted in those formal actions were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

WHEREAS, the Ohio Fire Prevention Code adopted by the Board of Trustees of Concord Township by Resolution #80-13 authorizes the establishment of fire lanes on public or private property as are deemed necessary for the efficient and effective operation of public safety vehicles and equipment; and

WHEREAS, the Board of Trustees of Concord Township desires to exercise its authority pursuant to R.C. 505.17 and the Ohio Fire Prevention Code to designate such additional fire lanes within the Township as are necessary to provide access to the property by public safety vehicles and equipment.

NOW, THEREFORE, BE IT RESOLVED: by the Board of Trustees of Concord Township, Lake County, as follows:

Section 1. Fire lanes shall be established and/or designated at the following locations within Concord Township, Lake County, Ohio, and as further described in the annexed Exhibit A:


