The Concord Township Board of Trustees met for a Public Hearing on September 4, 2019, at 7:15 pm., in Township Hall, located at 7229 Ravenna Road. Chairman Paul R. Malchesky called the meeting to order. Trustees present were Paul R. Malchesky and Caroline N. Luhta. Carl H. Dondorfer was absent.

It was established legal notice had been made.

The purpose of the meeting was to discuss the proposed Zoning Amendment Application #0719-1 by Auburn Career Center, requesting a Zoning Map Amendment on a portion of land currently known as Permanent Parcel Number 08-A-021-0-00-051-0, whose address is 8159 Auburn, as further described in Exhibit A, and being about 0.947 acres of land, from the current Zoning District of Gateway Business to the R-1, Residential District.

Heather Freeman, Zoning Director, stated the Lake County Planning Commission as well as at the Zoning Commission Public Hearing recommends approval (see transcripts for more details).

Jeff Slavkovsky, Executive Director of Career and Technical Education of Auburn Career Center, spoke about the proposed Zoning Map Amendment (see transcripts for more details).

Treasurer's Report:

- As of August 31st, we were 67% of the way through the calendar year. The Treasury Balance for the 19 active funds within the Township Treasury was \$4.8 million. The Treasury Balance includes \$625,000 in funds set aside for specific projects.
- Year-to-date expenditures were 55% of the amount appropriated for 2019. Revenue received year-to-date is 72%, which does not include receipt of the second half of our Real Estate Taxes. That money should be received in September.

B. FIRE DEPT. - Chief Sabo

Activities Report for August – 234 Total Runs; EMS 168 events with 106 transports; Fire – 5 Events (1 - structure fire in Concord, 1 - car fire outside Concord, 3 - mutual aid outside Concord); Mutual Aid Given – 27; Mutual Aid Received – 14; Fire Prevention Bureau: Plan Reviews – 1; Annual Inspections – 13; Fire Detection System – 5; Fire Protection System – 4; Complaint – 1; Adoption – 1; Consultation – 1; Public Education: Knox Box: installation – 2; Events: - 4.

Safety Tip: School bus traffic laws are listed in the Ohio Revised Code, Section 4511.75.

The basics include:

- Orange flashing lights=bus preparing to stop
- Red lights=Stop 10 feet from the school bus
- On a 2-lane road, all traffic must stop no matter which direction you are traveling
- On a road with 4 or more lanes, only traffic moving in the same direction as the bus must stop when
 the bus stops children are dropped off on the same side of the road as their homes, so they don't
 have to cross the street

C. SERVICE DEPT. - Frank Kraska, Service Director

- The Service Department has performed a wide range of activities during the past month, which included our Community Day event.
- We completed our community wide crack-sealing program for this season after dispensing over 27,000 pounds of mastic sealer in cracks and fissures on 67 Township roads throughout the community as well as our cemetery and Old Stone School parking area.
- As part of a Lake County Storm Water maintenance project, we cleared heavy overgrowth in the Nature Preserve South detention area with a brush hog and redefined the drainage swales within the portion of that detention that has a Concord Township easement encompassing it. In related work, we will also be modifying the outlet and repairing associated outlet structures at the Nature Preserve detention to maximize its designed functionality.
- Our concrete pavement replacement crew completed work on Andrea Drive and Hunters Trail and will be resuming activity in the Mountain Quail area in the coming weeks. This program replaces failed concrete slabs and often entire intersections within developments.
- Before the school year began and the opening of the new elementary school on Concord-Hambden Road, Township crews established a pedestrian path beginning on Ironwood Court and connecting to the new school located within a Concord Township easement and adjoining Concord green space property. The Service Department took great care to not disrupt the areas of foliage or cut down any mature trees unnecessarily near the path.
- Another Lake County Storm Water project was completed on Winchell Road that replaced the
 existing storm sewer crossover, which was failing on the outlet side, and further jeopardized the
 road integrity with a developing erosion condition on the valley side. This project included a new
 storm sewer crossover with a drop manhole and a massive headwall to prevent erosion and calm
 the water flow.
- Ellison Creek subdivision saw improvements to areas of road, which were settling and causing significant dips in the road at several locations. We contracted with Mitchell Construction to mill these areas and asphalt the cross sections to ultimately improve the driving conditions within that development.
- On Saturday September 21st from 8 am until 2 pm. Residents will have the opportunity to drop off brush and yard waste at our Service Department here on Ravenna Road behind Town Hall. Service Department personnel will be on hand to assist residents and help off load brush and yard waste as you arrive at the collection center. Brush dropped off will be chipped and made available to the residents on a first come first serve basis. Yard waste is collected and taken to a local recycle center and composted. Only limbs, twigs, and branches no greater than six inches in diameter will be accepted. Yard waste will only be accepted in biodegradable bags or small containers that can be dumped. No tree stumps, pallets, contaminated materials or processed wood such as lumber or railroad ties are accepted.
- A reminder to residents that we are continuing our yard waste drop-off on weekdays at the Service Department garage Monday through Friday 7:00 a.m. until 3:30 p.m.

D. ZONING DEPT. - Heather Freeman, Zoning Director

- During the month of August, the Zoning Department processed 29 zoning permit applications and collected \$3,550 in fees. Of those permits, 7 were for accessory buildings, 6 fences, 4 decks, 3 additions, 3 single family dwellings, 2 wall signs, 2 swimming pools, 1 accessory structure, and 1 directional sign.
- During the month of August, our office also received and began investigations on 32 new complaints about potential zoning violations. In addition, we performed 83 site inspections for open zoning permits.
- Last night the Zoning Commission held a public hearing for a zoning map amendment application request to rezone approximately 25 acres of land on Prouty Road from R-1 to R-3. This hearing has been recessed, and will continue at the October 1st Zoning Commission meeting.
- Next week the Board of Zoning Appeals will meet on Wednesday evening at 7 pm at Town Hall.
 There is one old case and one new case to be reviewed. The detailed agenda may be found on the Township website.
