DEPARTMENT REPORTS:

- A. ADMINISTRATION DEPT. Andy Rose, Administrator
 - Good evening. I want to take a few minutes to update you on the Fire Station project. We recently had a conference call with the architect and we discussed getting the cost estimate on the redesign as quickly as possible. We should have it this week. We also requested a separate quote in order to conduct a geo analysis on the soccer field site. The Fire Chief and I, along with Trustee McIntosh, have toured several area stations. Financing options continue to be explored in close coordination with our Fiscal Officer. I think it would be best to conduct a series of stakeholder meetings. These meetings can be used to inform all citizens on the fire station project and after the presentation, we can break out into several distinct groups i.e. architecture and building design, fire operations, and finance. Citizens will have the ability to discuss particular aspects that are focused on their area of interest. We will have follow up meetings in order to review comments and questions fielded and provide answers. This method allows ALL interested citizens the ability to participate. I recommend we conduct two meetings, one during the day and one in the evening.
 - On the agenda this evening are several personnel items requiring your vote. I recommend approval on all four of them. Two for the Service Department and two for the Fire Department.
 - Finally, I will be out of town starting tomorrow afternoon for the remainder of the week attending the Ohio Township Association's annual conference in Columbus. I'll be available by phone and email should you need anything.

A RESOLUTION AUTHORIZING THE NOTIFICATION OF INTENT TO CONDUCT AN INTERNET AUCTION FOR THE SALE OF UNNEEDED, OBSOLETE, OR UNFIT PERSONAL PROPERTY OF CONCORD TOWNSHIP FOR THE YEAR 2020.

WHEREAS, Ohio Revised Code Section 505.10(D) requires the Concord Township Board of Trustees to adopt a Resolution during each calendar year expressing its intent to dispose of surplus, unneeded, obsolete, or unfit personal property through the use of an internet auction; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Concord Township, Lake County, Ohio:

<u>Section 1</u>. That the Concord Township Board of Trustees hereby expresses its intent to dispose of surplus, unneeded, obsolete, or unfit personal property through the use of an internet auction during the calendar year 2020.

buyer will be responsible for removal of said items from the Concord Township facility within ten (10) days of receipt of said notification.

<u>Section 4</u>. That the number of days bidding for each auction, in accordance with Ohio Revised Code Section 505.10(D) will be at least fifteen (15) days, including Saturdays and Sundays, and holidays.

<u>Section 5.</u> That the Fiscal Officer shall publish in a newspaper of general circulation, notice of its intent to sell surplus, unneeded, obsolete, and unfit-for-use Township personal property by internet-based auction to be published once.

Section 6. That a similar notice shall be posted continuously throughout the calendar year in a conspicuous place in Concord Township Hall and in addition shall be posted continuously on the Concord Township website (<u>www.concordtwp.com</u>) with a link to GovDeals (<u>http://www.govdeals.com</u>), 5970 Carmichael Place, Montgomery, Alabama, 36117, phone (708) 714-2600, fax (334) 387-0519.

Section 7. That when property is to be sold by internet-based auction, the Concord Township Board of Trustees or its representatives reserve the right, at a later date, to establish a minimum price that will be accepted for specific items and may establish any other terms and conditions for the particular sale, including but not limited to requirements of pick-up or delivery, method of payment, and payment of sales tax in accordance with applicable laws.

Section 8. That such information shall be provided on the internet at the time of the auction and may be provided before that time upon request after the terms and conditions have been determined by the Board or its representatives.

<u>Section 9</u>. That the Board of Concord Township Trustees hereby authorizes the disposition of surplus, unneeded, obsolete, or unfit Township personal property via internet-based auction in calendar year 2017.
