This meeting was held via Webex Teleconference and YouTube Live Streaming.

The Concord Township Board of Trustees met for a Regular meeting on April 15, 2020, 7:31 pm, in Town Hall, located at 7229 Ravenna Road. Chairman Carl H. Dondorfer called the meeting to order and led in the Pledge of Allegiance. Trustees present were Amy L. Lucci, Carl H. Dondorfer and Morgan R. McIntosh.

APPROVAL OF MINUTES:

April 1, 2020 Public Hearing Meeting. Mr. McIntosh moved to approve the April 1, 2020 Public Hearing Minutes as written. Mrs. Lucci seconded. Vote 3 ayes.

April 1, 2020 Regular Trustees Meeting. Mrs. Lucci moved to approve the April 1, 2020 Regular Meeting Minutes as written. Mr. McIntosh seconded. Vote 2 ayes.

ELECTED OFFICIALS REPORT:

A. FISCAL OFFICER - Amy L. Dawson

My CPIM training in Columbus has been pushed back to later sometime this year. Two different purchase orders are on the agenda tonight for a snow plow truck. The original budget the Service Department was given for that truck was \$200,000 and they came in \$40,000 under budget for that particular purchase. This truck will be replacing a 2004 truck.

B. TRUSTEES:

Mrs. Lucci – Extended her support to the Concord Community during this awkward time; understand the concerns with not only health and safety but with the economic impact as well; confident that we are moving forward with intention to become stronger than ever; "Necessity is the mother of invention"-we have seen our community make masks and helping our seniors; it's more important now than ever for our community to be collaborative.

Mr. Dondorfer – I agree our community is facing challenging times; the Board of Trustees and Concord Township's offices are working collectively to keep the business of Concord Township moving forward; everyone's safety and well-being is definitely a concern; staying at home is difficult but think of it as not being stuck at home but safe at home; we will get through this together and we are here for you.

DEPARTMENT REPORT:

A. ADMINISTRATION DEPT. – Andy Rose, Administrator

Good evening. There are a few items on tonight's agenda I'd like to cover briefly.

- Item A under New Business Please remove this from the agenda. After discussions with our Law Director, this vote is not required.
- Item C and D under New Business relates to a new truck for the Service Department. This truck has been in the works and was budgeted for. It is a 2020 2-1/2 ton truck. It will replace a 2004 truck that has reached the end of its service life.

With regard to the COVID-19 virus, things remain the same for Concord Township:

- All Township controlled buildings continue to be closed to the public. Business is conducted via phone, fax, email, or regular mail. We have installed a drop box at the front door for anyone wishing to drop off paperwork. We will have someone checking Town Hall daily for mail and items in the drop box. Residents are encouraged to call or email if they have questions.

A few other items of note:

I accepted the resignation of Part Time Firefighter Brian Horvath on April 13, 2020. Brian has been with
us for just over 22 years. We thank him for his dedicated service to our community and wish him well
in his future endeavors.

- Yard waste can be dropped off by our residents at the Service Department. Hours for drop off are 7:30
 am to 2:30 pm. There is a yard waste dumpster and residents must drop off their own yard waste.
- Road work has started on Lancaster. That is a full concrete replacement and is expected to be completed by mid-July.
- Other road projects coming up are: Cali Woods area and Alexander/Bridlewood will be resurfaced next
 month. This is part of the joint resurfacing program with Painesville Township and Perry Village. The
 crews started in Perry Village and will work their way towards Concord. The County Engineers have
 informed us of their resurfacing projects which are scheduled to begin April 27 and will last to the end
 of July. These are:
 - Concord-Hambden Auburn Road to Ravenna Road
 - Morley Hoose Road to SR 44 Ramp
 - Pinecrest Morley Road to Hermitage Road
 - Old Johnnycake Ridge Ext SR 84 to 500 west of the intersection
- I continue to stay in regular contact with Lake County Mayors and Managers and we are all coordinating. We have regularly scheduled conference calls.
- I would like to make special mention of our Fire and Service Departments. They have done a terrific
 job of managing personnel to meet the needs of our community during these unusual times.
- Finally, there are local restaurants that remain open for carryout service. We encourage all of our residents to "shop local" when considering takeout food.
