### **RESOLUTION 2021-06**

A RESOLUTION BY THE CONCORD TOWNSHIP BOARD OF TRUSTEES AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO PREPARE AND SUBMIT AN APPLICATION TO THE OHIO DEPARTMENT OF NATURAL RESOURCES FOR A NATUREWORKS PROGRAM GRANT

WHEREAS, the State of Ohio through the Ohio Department of Natural Resources, administers financial assistance for public recreation purposes, through the federal Land and Water Conservation Fund Program and/or the State of Ohio NatureWorks Program; and

**WHEREAS,** the Township of Concord desires financial assistance under the NatureWorks Program.

# NOW THEREFORE BE IT RESOLVED:

**Section 1.** That the Board of Trustees for Concord Township hereby authorizes and instructs the Concord Township Administrator to prepare and file and application for financial assistance through the Ohio Department of Natural Resources, and to provide all necessary information and documentation to establish the Township's eligibility for this requested funding assistance.

**Section 2.** That the Township of Concord does agree to obligate and encumber the funds required to satisfactorily complete the proposed project and thereby become eligible for reimbursement under the terms of the NatureWorks Program.

**Section 3.** It is found and determined that all formal actions by the Board of Trustees of Concord Township concerning and relating to the adoption of this Resolution were taken in an open meeting of the Board of Trustees of Concord Township and that all deliberations of this Board
