Mr. Massie of 8196 Rainbow Drive discussed his research on the impact COVID had on Riverside Schools. He showed an eight percent drop in proficiency scores across the board.

He then asked if the Flock Cameras have facial recognition. Mr. Dondorfer answered "no" and further explained how the Flock Cameras work and their purpose.
