We would like to 2 commence the public hearing here on May 17th for the petition 3 of landowner and business owner seeking to be included in the 4 Concord Township-City of Painesville Joint Economic 5 Development District, or the JEDD. That request has been 6 submitted by Normandy Properties Limited Partnership and 7 property owner, Sheetz, Inc., owner of business, at permanent 8 parcel number 08-A-020-0-00-053-0. 9

10 So this is a public hearing about having them join 11 the JEDD. And I believe we have the Administrator of the JEDD 12 here this evening, Rita McMahon, to give us a briefing and 13 public comment on this.

15 CHAIRMAN McINTOSH: I just want to add that the 16 notice was properly made in a timely manner for this public 17 hearing. Thank you.

18 MS. MCMAHON: Thank you. Good evening. This is the 19 Sixth Amendment that we are bringing forward to the JEDD 20 contract that was first executed in 2008. As was just 21 indicated, this is for the property that's located at the 22 southwest corner of Capital Parkway and State Route 44. It's 23 the location where the new Sheetz is under construction. Ιt 24 is the first petition we have received that is both from the 25 property owner and the business that is being located, that 26 will be located in the JEDD, so that's something a little bit 27 different.

28 This will be the 22nd parcel that will be in the 29 JEDD. We started with 4 and now we're up to, we're up to 22. 30 As is indicated, it will be the future site of the Sheetz,

which will be both for fuel and a convenience store and food, 1 et cetera, that they have. 2 In order to amend and add parcels into the JEDD, a 3 public hearing needs to be held by both the City of 4 Painesville and Concord Township. Both entities have to 5 6 accept the parcel to come into the JEDD. Monday, this past Monday, on the 15th, the City of Painesville held their public 7 hearing and passed their resolution to accept this parcel into 8 the JEDD. If the Trustees tonight do the same, then we will 9 10 proceed to notify the Ohio Department of Development for, that our JEDD has been expanded and added onto the additional 11 12 parcel. I can answer any questions you may have. 13 MS. LUCCI: I don't. 14 CHAIRMAN McINTOSH: I don't have any questions. 15 MS. LUCCI: No questions. Thank you. 16 CHAIRMAN McINTOSH: Thank you, Rita. 17 MS. McMAHON: You are welcome. 18 CHAIRMAN McINTOSH: All right.
