RESOLUTION NO. 2024-29

A RESOLUTION AUTHORIZING THE BOARD OF TRUSTEES FOR CONCORD TOWNSHIP TO ENTER INTO A WRITTEN CONTRACT WITH THE LAKE COUNTY SHERIFF'S DEPARTMENT FOR POLICE PROTECTION.

WHEREAS, pursuant to Section 504.16 of the Ohio Revised Code, the Concord Township Board of Trustees is required to provide for police protection services within Concord Township;

WHEREAS, Concord Township is desirous of continuing police protection from the Lake County Sheriff's Department for the unincorporated areas of Concord Township and its property and residents on a regular and consistent basis; and

WHEREAS, the Township may provide for such police protection through a written contract with the Lake County Sheriff's Department, pursuant to Section 505.43 of the Ohio Revised Code; and

WHEREAS, such police protection pursuant to written contract will enhance the preservation of the public peace and safety in the Township and is in the best interests of the Township residents;

NOW, THEREFORE, BE IT RESOLVED by the Concord Township Board of Trustees, Lake County, Ohio, that:

<u>Section 1</u>. The Board of Trustees is hereby authorized to enter into the written Contract for Police Protection with the Lake County Sheriff's Department, in a form substantially similar to the Contract annexed as Exhibit A and incorporated herein, and to execute any and all documentation necessary to formalize the validity and implementation of that Contract.

<u>Section 2</u>. Upon majority vote, the Board dispenses with the requirement that this Resolution be read on two separate days and authorizes adoption of this Resolution upon its first reading.

<u>Section 3</u>. If any section, phrase, sentence, or portion of this Resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

<u>Section 4</u>. It is found and determined that all formal actions of the Board of Trustees of Concord Township concerning and relating to the adoption of this Resolution were taken in an open meeting of the Board of Trustees of Concord Township and that all deliberations of this Board that resulted in those formal actions were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

<u>Section 5</u>. This Resolution constitutes an emergency measure necessary for the immediate preservation of the public health, safety, and general welfare, and for the further reason to implement the Contract for police protection on the effective date of January 1, 2025, and for these reasons, this resolution shall be effective upon its passage per Section 504.11 of the Ohio Revised Code.

THEREFORE, this Resolution shall be in full force and effect immediately upon its passage and approval by the Board of Trustees.
