



Zoning Information Sheet #7: Single Family Dwellings

1) What are the zoning requirements for constructing a new single family dwelling?

• The following applies to property in the R-1, R-2: RCD, R-4, R-6, and R-8 Districts. Other residential zoning classifications may apply to your property. Contact the Zoning Department office to verify.

Min. Driveway setback	3 FT from property lines

Maximum improved parking/drive area	40% of front yard	n/a	40% of front yard	40% of front yard	40% of front yard

(1) Corner lots shall provide the minimum front building setback from both road right-of-ways.

(1) Refer to the Concord Township Zoning Resolution for maximum attached garage sizes in Section XV.

2) What is needed to complete a zoning permit application for a single family dwelling?

- Minimum of two (2) copies of site plan (drawn to scale) prepared by a registered surveyor
- 1 set of building plans
- The appropriate fee as followed:
 - \$400 Single Family Detached
 - o \$700 Two-Family Duplex
 - \$400 + \$200 per unit Multi-family/Townhouse
- Completed Zoning permit application

3) What other approvals are needed?

- Lake County Engineers (440) 350-2770
- Lake County Soil and Water Conservation District (440) 350-2730
- Lake County Building Department (440) 350-2636
- Lake County Dept. of Utilities (sanitary sewer) (440) 350-2645
- Lake County Health District (on-site septic) (440) 350-2543
- Your Homeowners Association may require additional review, and may have other restrictions on items such as minimum square footage, building materials, and locational requirements.
