Minutes of Concord Township Board of Trustees Special Meeting Held on February 19, 2025

The Concord Township Board of Trustees met with Chardon Township Trustees in a Special Joint Meeting on February 19, 2025, at 5:00 p.m., in the Conference Room of Town Hall, located at 7229 Ravenna Road. The purpose of the meeting was to discuss road improvements on shared roads and to sign the 2025 Road Maintenance Agreement.

A discussion was held regarding the resurfacing of Little Mountain Road. Chardon Township agrees with Concord Township that the road needs to be resurfaced. Chardon Township will inform Concord Township by Mid-March if they can fund their portion this year or 2026. It was agreed that the road will be resurfaced no later than 2026.
